

Myopia Management with Stellest Spectacle Lenses Program Agreement

1. Introduction:

The Essilor Stellest lens is the first and only FDA market authorized spectacle lens clinically proven to slow myopia progression in children. The efficacy of this lens is evidenced by clinical data showing that the lens slowed down myopia progression by 71% on average over two years^{1,2}.

Slowing of myopia progression is expected but not guaranteed. We are excited to journey together with your family in this program now and into the future. We are committed to being available on this journey and we ask for your commitment to the visit schedule and Stellest spectacle lenses wear expectations.

2. Wear Time

The children in the clinical trial were asked to wear their Stellest spectacle lenses ≥ 10 hours per day and ≥ 6 days per week.

3. Safety Information

No difference in subjective vision reports between Essilor Stellest lenses and single vision lenses over 2 years in study. Reports of blurred vision and halos were similar between the two groups.

4. Follow-Up Visits

This is an expected visit schedule to monitor your child's progression. Your doctor will determine the most appropriate interval and number of visits.

5. Costs

Program fee (each year): doctor's service fee + frame (cost varies) + Stellest lenses \$450.

Itemized doctor's service fee:

- Axial length measurement \$75, recommended once a year
- Stellest dispense \$50
- 6-month refraction \$75

Essilor offers a one-time, no charge replacement of Essilor Stellest lenses if, at the 6-month follow-up, the prescribing doctor determines a change in Rx of 0.50D or worse from the initial Rx; Replacement orders must be placed within 9 months of the original order date.
